Conduct

1. Act in the best interests of service users
2. Respect the confidentiality and privacy of service users, peers and colleagues
3. Maintain high standards of personal conduct and behaviour
4. Use social media responsibly
5. Comply with obligations regarding preparation for practice placement

Performance

6. Address health issues related to your fitness to practise
7. Obey laws, regulations and guidelines
8. Comply with requirements for the protection of children and vulnerable adults
9. Act within the limits of your knowledge, skills, competence and experience
10. Keep your professional knowledge and skills up to date
11. Obtain consent from service users
12. Assess service users' capacity to consent where necessary
13. Communicate effectively with service users and others involved in their care
14. Act in accordance with the principles of open disclosure

15. Keep accurate records
16. Assess health, safety and welfare risks
17. Raise concerns about safety and quality of care

18. Demonstrate ethical awareness
19. Respect the rights and dignity of service users, peers and colleagues
20. Avoid conflicts of interest
21. Undertake research in an ethical manner
