### Applying for the Stamp 1G

- To apply for the Stamp 1G you need:
- Ø A statement of your final results
- Ø Valid passport
- Ø IRP card
- Ø Evidence of private medical insurance (purchased in Ireland)
- Ø Credit /debit card payment of €300

## **General Employment Permits**

Issued with Stamp 1 Generally issued for 2 years and then can be renewed for further 3 years Short visa option available – 6 months or less Applications can be made by the employer or the employee May apply for long-term residency after 5 years May bring family after 12 month – not eligible to work All jobs are eligible unless excluded under the list of Cost: €500 for 6 months or less, €1,000 up to 24 months

- Applicants **must** be qualified or have necessary experience
- €27,000 minimum salary for graduates
- **Must** have a job offer directly from an employer registered in Ireland
- Generally application **must** be made 12 weeks before start employment start date
- Most employers may not have more than 50% non-EU employees
- •A labour market test **must** be done DSP Employment
  Services/EURES employment network (4 week advertisement)
  •Newspaper (3 days)
